PROBLEM STATEMENT



A global pharmaceutical company offering oncology and immunotherapy products was under pressure to ensure strict regulatory compliance and traceability across its prescription-to-dispensation lifecycle in high-risk medications.

Manual prescriptions caused errors among HCPs and pharmacists.

No centralized system for eligibility and drug tracking.


Compliance gaps with GAMP 5 and GDPR made audits risky.

Delays in documentation and communication.



INT. a Delivered a secure **Pharmacovigilance Platform**, automating the cycle from prescription to fulfillment.

- ✓ **Digital Prescription Portal:** Healthcare professionals submit treatment requests with documentation and patient info.
- ✓ **Medical Coordinator Validation:** Requests are reviewed for approval or returned for revisions.
- ✓ **Pharmacist Interface:** Dispensation occurs after approval, with a digital acknowledgment process.
- ✓ **Audit Trail & Compliance:** Maintains a time-stamped record of actions, ensuring data security and adherence to regulations.
- ✓ **Role-Based Access:** Ensured data security, PII masking, and therapy-level access rights


